<u>COUNT ONE —OFFERING A FALSE INSTRUMENT FOR FILING IN THE FIRST DEGREE, AN E FELONY, IN VIOLATION OF SECTION 175.35(1) OF THE PENAL LAW OF THE STATE OF NEW YORK</u>

COUNT ONE

In that: A person is guilty of offering a false instrument for filing in the first degree when knowing that a written instrument contains a false statement or false information, and with intent to defraud the state or any political subdivision, public authority or public benefit corporation of the state, he or she offers or presents it to a public office, public servant, public authority or public benefit corporation with the knowledge or belief that it will be filed with, registered or recorded in or otherwise become a part of the records of such public office, public servant, public authority or public benefit corporation.

TO WIT: The defendant, Allstate Enterprises Inc., in the Town of Huntington, County of Suffolk, State of New York, on or about June 27, 2018, did present to a representative of the Huntington Union Free School District, for a district wide capital improvement project, Payment Bond number CSC225221, and Performance Bond number CSC225221, each dated June 26, 2018, which appeared to have been issued by Colonial Surety Company on behalf of the defendants company, Allstate Enterprises Inc. The Payment Bond and Performance Bond were later determined to be fraudulent documents by Colonial Surety Company, who had no record of ever having issued said bonds. Colonial Surety additionally reports that bond number CSC-225221corresponds to bonds issued by Colonial on behalf of a different principal for a different project.

This complaint is based on information and belief, the source of said information and belief being the supporting deposition of George Austin, dated 1/23/2020, and Forgery Affidavit of Philip Shepard, dated 2/21/2020.

COUNT TWO- WILLFUL FAILURE TO FILE PAYROLL RECORDS WITHIN THE DEPARTMENT OF JURISDICTION, AN E FELONY, IN VIOLATION OF SECTION 220. 3- a(a)(iii) OF THE LABOR LAW OF THE STATE OF NEW YORK

COUNT TWO

IN THAT: A person is guilty of failure to file payroll records with the department of jurisdiction when a contractor or subcontractor fails to submit to the department of jurisdiction, within 30 days after the issuance of its first payroll, and every thirty days thereafter, a transcript of the original payroll record, setting forth the names and addresses and showing for each worker, laborer, or mechanic the hours and days worked, the occupations worked, the hourly wage rates paid and the supplements paid, or provided, subscribed and sworn to or affirmed as true under the penalties of perjury.

TO WIT: The defendant, Tosif Siddiqi, in the Town of Huntington, County of Suffolk, State of New York, on or about and between June 23, 2018 and June 29, 2018, in his capacity as owner of Allstate Enterprises Inc., did fail to submit to the Huntington Union Free School District, within 30 days after the issuance of its first payroll, a transcript of the original payroll record in the form of a Certified Payroll for a district wide capital improvement project.

This complaint is based on personal knowledge and your deponents review of all submitted certified payrolls.
